**WITH A PRE-TOURNAMENT MEETING AT THE STAGE AT 6:40 AM SHARP! ALL PARTICIPANTS, PER-REGISTERED OR NOT, WILL HAVE LIVEWELLS CHECKED AND BOAT LAUNCHED BEFORE CHECKING IN/REGISTERING. NO EXCEPTIONS! WE DON'T WANT OT DELAY THE TOURNAMENT.**

**ENTRIES MUST BE PAID IN US FUNDS ONLY. CANADIAN ENTRIES NEED TO BE PAID BY MONEY ORDER PAYABLE IN US FUNDS, OR CASH. RULES: NO LIVE BAIT. NO TROLLING. NO FISHING RESTRICTED WATERS. THERE IS A MAXIMUM 2 ANGLERS PER BOAT WITH A 2 FISH LIMIT PER TEAM ON LAKE ERIE WITH A MINIMUM SIZE OF 20". FISH MUST BE BLACK BASS ONLY. LIFE JACKETS MUST BE WORN WHEN COMBUSTION ENGINE IS RUNNING. ANYONE LATE WILL INCUR A ONE LB PER MINUTE PENALTY - AFTER 5 MINUTES - DISQUALIFIED. ANY SHORT FISH BROUGHT TO WEIGH-IN WILL RESULT IN **IMMEDIATE DISQUALIFICATION**. THERE IS A ONE POUND PENALTY FOR DEAD FISH. LUNKER MUST BE ALIVE TO COLLECT LUNKER PRIZE. TIES FOR ALL PLACES WILL BE BROKEN BY THAT TEAM'S LARGEST FISH. IF STILL TIED, A ONE HOUR FISH-OFF (FIRST PLACE ONLY) WILL TAKE PLACE. ALL OTHER PLACES - PRIZES WILL BE COMBINED AND EVENLY DISTRIBUTED. ANY TIE FOR LUNKER WILL BE BROKEN BY THAT TEAM'S TOTAL WEIGHT. WE DON'T WANT TO BE SENDING BOATS OUT LOOKING FOR YOU! ANY DEAD FISH ARE THE RESPONSIBILITY OF THE ANGLER, CULLING OF DEAD FISH WILL RESULT IN IMMEDIATE DISQUALIFICATION. ONLY ONE ROD PER PERSON MAY BE USED AT ONE TIME. All taxes are the winners' responsibility.**
