LIFE JACKETS MUST BE WORN WHEN COMBUSTION ENGINE IS RUNNING. ANYONE LATE WILL INCUR A ONE LB PER MINUTE PENALTY, AFTER 10 MINUTES-DISQUALIFIED. SHORT FISH BROUGHT TO WEIGH-IN, immediate disqualification. One pound PENALTY FOR DEAD FISH. LUNKER MUST BE ALIVE TO COLLECT LUNKER PRIZE. TIES FOR ALL PLACES WILL BE BROKEN BY THAT TEAM'S LARGEST FISH. IF STILL TIED, A ONE HOUR FISH-OFF (FIRST PLACE ONLY). ALL OTHER PLACES/PRIZES WILL BE COMBINED AND EVENLY DISTRIBUTED.
